



**I, the undersigned, do hereby accept the following terms as an official Member of the Vanderstank Family of Universal Cosmic Knowledge (“The Family”) and/or of former or continuing employment (herein included under the terms of Membership) as a Vanderstank Active Corrections and Reconnaissance Officer (VACRO) as defined under the existence of the former Vanderstank Industries, Ltd. (“The Company”):**

- I. **Family First.** I, the undersigned, do understand that by applying for membership in the Vanderstank Family. I have vowed to place the duties and commitments of this role ahead of those of my biological family, friends, and any other external parties not related to Family operations, and that under **no circumstances** shall the full terms of my Membership shall be disclosed to said parties unless expressly authorized by a member of the Reality Advisory Board (herein referred to as the “Board”). I understand that over time the Vanderstank Family is to become my primary family, with all other interpersonal relationships to become secondary to the Family.
- II. **Previous Beliefs.** I, the undersigned, do hereby announce my willingness to denounce and separate myself entirely from any previously held religious or spiritual beliefs of any kind if requested to do so by a member of the Church of Vanderstank or the Reality Advisory Board, and pledge to extinguish them completely and entirely from my mind at all times, in order to allow for maximum reception of the teachings of the Church of Vanderstank. I understand that the compatibility of my previously held beliefs may be discussed with an approved Vanderstank Spiritual Advisor at a future time in my Membership, but until such time, any and all religious or spiritual beliefs **must** be approved by and align with the teachings of the Church of Vanderstank.
- III. **Media.** I, the undersigned, do understand that any media I produce that features, mentions, or references the Vanderstank Family or any associated organization in any way becomes the intellectual property of the Family and may be used at any time for any purpose, including but not limited to usage in promotional materials.
- IV. **The Understanding.** I, the undersigned, do assert that my desire to join the Family is born of a shared understanding of the future of humanity at large, as outlined in The Understanding, formerly referred to as The Agreement or The Claustrum Agreement. I understand that my agreement with the terms of The Understanding is inherent in my understanding of the future of humanity, regardless of whether or not I have been provided the opportunity to read or fully comprehend the document at this time, and I understand that my time as a Family member will serve to inform and educate me in regards to the Understanding, the full text of which may or may not be made available to me at a later date depending on my progress and/or contributions to the Family mission.

- V. **Slander.** I, the undersigned, do hereby vow never to engage in any disparaging or slanderous discourse or rumination about the past, present, or future activities of the Vanderstank Family, the former Vanderstank Industries Ltd., or any of its associated entities, or insinuate continuing collaboration with any formerly related entities including but not limited to the former Hazardous Operational Byproduct Expunction Operations (HazOBEO) or any of its bureaus. Furthermore, I vow to expunge these thoughts from my mind entirely and understand that if at any time I find my thoughts wandering in this direction, it is my accepted duty to terminate my own membership from the Family.
- VI. **Sensitive Information.** I, the undersigned, do understand that my role in the Vanderstank Family may require the handling of sensitive and/or personal information, information concerning the classified locations of various persons and places, and/or other information related to classified internal operations, whose operation may or may not fall within the gray area of the law. I understand that the confidentiality of this information is critical to the success of the Family, and is being used for the Greater Good of the Human Race. I therefore agree to hold this information in the strictest confidence, to take all reasonable precautions to protect such information, and not to disclose any such information or any information derived therefrom to **any person(s) whatsoever**, with the exception of members of the Reality Advisory Board. I understand that if at any time it is unclear whether information should be treated as classified, I shall treat it as classified under the terms of this contract. I understand that disclosure of this information to any non-Member or Member without proper security clearance will result in my immediate termination from the Family and the construction of a legal countersuit which you will be entirely unable to win.
- VII. **Litigation.** I, the undersigned, do understand that my Membership in the Vanderstank Family is not bound by any labor laws or regulations, and that the Vanderstank Family is not legally responsible for my personal safety or well-being. I understand that my role in any internal operations is to remain classified under all circumstances, and in order to ensure this confidentiality, I therefore waive all rights to discuss my treatment while in the Family, or to file or engage in any public or private legal disputes regarding my personal safety and well-being as a result of Family policies including but not limited to those outlined in this document. Any legal disputes of any kind are hereby nullified according to the terms of this contract.
- VIII. **Psychological condition.** I, the undersigned, do hereby certify that I am of a consistently stable psychological condition suitable to allow for reliable work for the Family according to the terms of this agreement. Furthermore, I understand that any change to my psychological condition that occurs during my time at the Family, intentional or otherwise, is being performed in my best interest and does not constitute brainwashing or any legally binding form of abuse or mistreatment. In return, I understand that any Family-approved adjustment that I perform to the psychological condition of any other person(s) during the course of my Membership is hereby protected by the terms of this agreement.
- IX. **VACRO.** I, the undersigned, do understand that my membership in the Vanderstank Family constitutes voluntary acceptance of the duties of a Vanderstank Active Corrections and Reconnaissance Officer (VACRO) as defined during the existence of the former Vanderstank Industries, Ltd. to be called upon at any time, should the need arise, and that unwillingness to perform these duties is grounds for immediate termination.
- X. **Identity.** I, the undersigned, do understand that my identity within the Vanderstank Family is first and foremost as a Family Member, and as such the Family retains the right to alter, add to, or remove features from my identity at will, immediately or retroactively, with or without notification. I act primarily as a body part to the Family's body, the parts of which it may modify at will.
- XI. **Fluids & Tissues.** I, the undersigned, do authorize the collection, storage, and analysis of my blood and/or other bodily fluids and/or tissue by the Family. I understand that this procedure, and any and all other procedures related to the collection of this material, are not to be treated as a "medical procedure" in any legally binding sense, and that I will take any and all reasonable precautions to conceal the nature of these procedures from any and all person(s) outside the Family. I hereby release the Family and its employees and partners from any and all liability related to this procedure or any related procedure(s) or the effects thereof. Furthermore, I do hereby state my wish that upon my death, the Vanderstank Family shall take legal ownership and custody of my remains.
- XII. **Termination.** I, the undersigned, do understand that my Membership may be terminated at any time, immediately or retroactively, with or without notice, either by violating the terms of this agreement, apathy or inconsistent communication, impersonation or false pretense, insubordination, or at the whim of the Reality Advisory Board, and that if terminated, the Family, not me or any other entity, shall set the official terms, reason, and method of disclosure (if any) of the termination. I also understand that termination or suspension from the Family does not nullify the terms of this contract and they will remain binding.
- XIII. **Modification.** I, the undersigned, do understand that the terms of this contract may be altered at any time, effective immediately or retroactively, with or without notice.
